ARTICLE ONE

Definitions

In addition to the Definition of "Common Properties" in Definition #5, the Common Properties also may be referred to as the "Green Spaces", "Greenways", and/or "Common Areas" of the Association and includes all references in said document, and other documents, meeting minutes, newsletters, and other material of the association.

10. Legal Description of "Common Properties" and "Common Areas" of the "Association" are as follows:

A track of land in Section 34, T. 1 S., R. 2 E., of the W.M. in the County of Clackamas and State of Oregon, described as follows:

Beginning at the Northwest corner of the Northeast one-quarter of the Southwest one-quarter of said Section; thence South 0° 08' East along the Westerly line of said Parcel I, a distance of 471.94 feet to the true point of beginning of the tract herein to be described; thence South 0° 08' West along the Westerly line of Parcel I and 2 of said tract 857.71 feet to an iron pipe at the Southwest corner of said Parcel 2; thence South 89° 24' East along the south line of said Parcel 2, a distance of 299.00 feed to the Southeast corner thereof; thence North 0° 08' West along the Easterly line of Parcel I and 2, a distance of 857.71 feed to an iron pipe at the angles corner in said Parcel I, thence North 89° 24' West 299.00 feed to true point of beginning.

A tract of land in Section 34, Township 1 South, Range 2 East, of the Willamette Meridian, in Clackamas County, Oregon, described as follows:

Beginning at a point which bears North 1291.82 feet and West 8.79 feet from the center of said Section; thence North 6° 14' 45" East, 85 feet along the west line of Valley View Terrace County Road No. 2379 to the southeast corner of Vista View Village, a recorded plat; thence North 83° 45' 15" West along the south line of said Vista View Village and Tract B of Vista View Village No. 2, a recorded plat, a distance of 396 feet to the true point of beginning; thence South 6° 14' 45" West along an interior line of said Tract B, 110 feet to an angle corner therein; thence South 83° 45' 15" East along an interior line of said Tract B, 65 feet to a point; thence North 6° 14' 45" East parallel with the west line of said Valley View Terrace Road, 110 feet to a point in an interior line of said Tract B; thence North 83° 45' 15" West along said interior line, 65 feet to the true point of beginning.
