September 12, 2023 - Vista View Village Annual Board Meeting Minutes

- I. Bill opened the meeting at 7:05pm.
- II. Board members discussed the recent vandalism at Greenspace #1. Debbie will email the Neighborhood Watch. Debbie moved to give Bill the authority to buy a new door for the shed if he deems necessary. Hannah seconded.
- III. Hannah noticed an error in the minutes from the August meeting and stated she would change the previous approved minutes from the "May" minutes to the "July" minutes. Erin moved to approve the minutes as amended. Lona seconded. The motion passed by majority vote.
- IV. Old Business:
 - A. Bill announced next board meeting on October 3, 2023.
 - B. Bill recapped the annual meeting. Hannah relayed the results of the nominations.
 - C. Bill discussed the community picnic from the previous weekend and requested further feedback. Lona suggested a port-a-potty and an additional paper notice of that meeting. Erin suggested additional use of the sandwich boards for these events as well. Debbie suggested created a little more space between the annual meeting and the picnic.
 - D. Considering June date for summer meeting with target for September 7, 2024 for next summer picnic.
- V. New Business
 - A. Bill suggested October 14th for a clean-up day in the Greenspace ditch. Debbie and Lona recommended coordinating with Dennis Gale who has been doing most of the maintenance and putting it on the member calendar.
 - B. Bill discussed certified letter received from neighbor to the HOA. Bill reported that he had gone and had a conversation with the neighbor, and he originally seemed affable. He has since threatened to file a suit in small claims court against the HOA and WES. Members discussed the possibility of a good-faith, preemptive settlement offer. He said that WES gave him \$650. He has demanded the remainder of his \$1,367 alleged damages be covered by the HOA.
 - 1. Hannah moved to approve \$720 settlement offer. Lona seconded. The motion passed by a majority vote.

 - A. Lona reported that progress has been slow on the review, but we're making progress.
- VII. Treasurer's Report: Lona
